Symposium Speakers



Mark C. Long

Mark Long joined the Evans School faculty in 2004 and is the professor of public affairs and adjunct professor of economics. Mark holds a Ph.D. and MA in economics from the University of Michigan. He also holds an MPP from the University of Michigan, and a BA from DePauw University. Mark is affiliated with several centers including Scholars Strategy Network, West Coast Poverty Center, Center for Education Data and Research, and the Center for Studies in Demography and Ecology.

Mark's research examines the effects of public policies (particularly education policy) on economic opportunity and efficient social mobility, with emphasis on estimating the benefits and costs of those policies. Mark has previously worked on the economics of nursing labor markets and manufacturing firms' wage and productivity dynamics, and here recently, provided research findings on the effects of Seattle's minimum wage increase on the economy.

Mark previously served on the faculty of George Washington University as an assistant professor of economics and public policy and administration from 2002 to 2004. He has publications in numerous journals including *The Review of Economics and Statistics*, *Journal of Public Economics*, *Journal of Econometrics*, *Journal of Policy Analysis and Management*, *Public Administration Review*, *American Educational Research Journal*, *Educational Evaluation and Policy Analysis*, and *Educational Researcher*.



Cynthia Forland

Cynthia Forland has served as the director of Labor Market and Performance Analysis (formerly Labor Market and Economic Analysis) with the Employment Security Department (ESD) for over two years, having served as ESD's director of research and policy since early 2011. Cynthia previously worked as a research and policy analyst for the Washington and New Jersey State Legislatures, primarily in the areas of health and human services. This included over five years with Washington State Legislature's Joint Legislative Audit and Review Committee. Cynthia has a Ph.D. in political philosophy from the New School for Social Research in New York.



Scott Bailey

Scott Bailey has served as the Southwest Washington regional labor economist for Employment Security's Labor Market and Performance Analysis Office for more than 20 years. Scott works closely with economic development and workforce development organizations in the region. He received his master's degree in economics from Portland State University and is a board member of the Pacific Northwest Regional Economics Conference. Scott has done extensive research on wages in the state, and has served as a national trainer with the U.S. Census Bureau for the Local Employment Dynamics database.

Anneliese Vance-Sherman

Anneliese Vance-Sherman is the regional labor market economist covering Island, King, San Juan, Skagit, Snohomish and Whatcom counties for the Employment Security Department (ESD). She has been with ESD for four years. Prior to state service, Anneliese was a visiting fellow at the Border Policy Research Institute at Western Washington University and taught courses in economics, geography and management. She has a Ph.D. in economic geography and a master's degree in economics both from the State University of New York at Buffalo. Her undergraduate studies were in sociology and urban studies.



Byron Mukai

Byron Mukai is an operations management analyst with the Labor Market and Performance Analysis Office and holds a master's degree in public administration from The Evergreen State College. Byron is the primary contact for LMPA's Labor Market Information Center (LMIC) and also assists with data tools and processes on LMPA's employment data website. Byron previously worked as a cost reimbursement analyst at the Washington State Department of Corrections with the Health Services Division. He also has a background as an operations and distribution manager in industrial supply and transportation industries.



Ryan Leisinger

Ryan Leisinger is the assistant deputy director of application configuration with the Employment Security Department. Ryan was instrumental in the launch of the employment data website in 2011 and has worked to continually improve how the site delivers its information and data. Ryan worked with senior leadership at ESD concerning House Bill 2202 (which created a policy mandating open data for Washington state departments) and has continued to work with the Office of the Chief Information Officer on various stages of a Washington state open-data initiative. Ryan is active in the open-data community having contributed code to several open-source and open-data projects, tested beta versions of open-data platforms and submitted data sets to open-data portals.

Driving directions from I-5:

Southbound – From Interstate 5 take State Capitol Exit #105A.

Northbound – From Interstate 5, take State Capitol Exit #105.

1. At the round about on 14th and Jefferson, take right on Jefferson Street.
2. Take left at second signal onto 11th Street.
3. Take left at signal onto Washington Street
4. Take first left off Washington Street to enter NRB Parking lot.

Parking:

Office Building 2 (OB2) is located on Olympia's Capital Campus. Parking is located at the P1 parking lot at the Natural Resources Building (NRB).
